Appearance	The formal document sent to the Probate Registry and the person that

Breach of Trust	An act (or failure to act) by a Trustee that is not authorised by the Trust

Court Order	An order made by the court deciding the outcome of a claim;

Deed of Variation	A legal document made in writing and signed by a relevant parties that

Estate	The property, money and belongings that were owned by the Deceased
Estato	immediately before their death;
Executors	The persons named in a Will that are responsible for
	Administering/Distributing an Estate;
Grant of Letters of Administration	A legal document issued by the Probate Registry when someone dies
	without a Will. This gives the Administrator the authority to sell and
	transfer the Deceased's Estate;
Grant of Probate	A legal document issued by the Probate Registry when someone dies
	that confirms an Executor has the authority to sell and transfer the
	Deceased's Estate;
Intestate	When someone dies without a Will;
Issue	The children of a Deceased;
Limitation	The time limit which applies to making a claim. If the claim is not made
	within the prescribed limit, the court can decide that it will not hear the
Madiation	claim;
Mediation	The process of settling a case out of court, whereby the parties meet together and a neutral third person goes between the parties trying to
	find common ground and to facilitate agreement;
Mutual Wills	Wills made by two or more people who agree not to revoke or change

Mental Capacity	The mental understanding required by law for a person to make a Will;

Permanent Caveat	A Caveat that can only be removed by the consent of the parties or by a

Proceedings	The action taken in order to resolve a matter at court;
Testate	When a person dies leaving a Will;
Testator	The person who has made a will or given a legacy;
Trustee	The person appointed to manage property for the benefit of another

Trust	The legal arrangement used to appoint someone to manage property for
Tantata	the benefit of another person;
Testate	When a person dies leaving a Will;

Undertaking	A promise made by a solicitor to do something. Breach of a solicitor's undertaking is a matter of professional misconduct;
Warning	A document issued by someone challenging a Caveat. The Warning demands than an Appearance is made within eight days by the person that entered the Caveat. If no Appearance has been entered, then the Grant of Probate can then be issued;
Settlement Agreement	The private agreement reached voluntarily by the parties which brings an end to the dispute;
Undue influence	The process of coercing a Testator into making a Will that they did not wish to make;
Will	A legal document that decides what happens to property belonging to a Deceased upon their death.
